NOW HIRING: Emergency Readiness Coordinator /CRI

The Emergency Readiness Coordinator works on the Cities Readiness Initiative, and is expected to review internal operating and grant procedures, maintain compliance with guidelines from national and state agencies which include the Operational Readiness Review (ORR) and Point of Dispensing (POD) site security standards. Coordination of all aspects of the Franklin County Public Health CRI Program will include:

- Write, update and implement emergency preparedness policies, plans and briefings detailing processes of response and necessary steps of the agency.
- Develop measurable improvement processes and implement findings in After Action Reports
- Manage Inventory Management and Tracking System (IMATS) of emergency preparedness equipment and Personal Protective Equipment (PPE)
- Ensure effective planning, logistics, communications, and safety at designated points of dispensing (POD) sites throughout Franklin County
- Assist with writing, editing, and collecting documentation to assure grant compliance and meet established programmatic deliverables.
- Oversee the training and testing of plans, policies, and procedures through the leadership of tabletop discussion, drills, and functional or full scale exercises with both internal and external partners.
- Other related duties as assigned.

Requirements:

- Must have a Bachelor's degree in public health, public administration, emergency management, environmental sciences, or related field.
- At least 1 year of related emergency preparedness experience.
- Must possess a valid driver's license, and be insurable through FCPH's provider; some evening and weekend hours required.
